

First Step Alliance is pleased to share with you our *2022 Impact Report*, highlighting our accomplishments during the year and our plans for 2023. We are incredibly grateful to our passionate and talented Board of Trustees & Officers, Advisory Council members, interns, and other volunteers who contributed their time, treasure, and talent to help end systemic discrimination in financial services.

In 2022, we made significant progress in advancing our programmatic initiatives to improve access to affordable financial services for justice-involved people. We continued to expand our *Fresh Start Financial Education & Banking Program* partnerships across the country. Through speaking engagements, webinars, cohort participation, published articles, and signing on to criminal justice reform initiatives, we shared our knowledge on important issues, increased awareness of our programs, and advocated on behalf of our community members. We also moved closer to realizing our vision to start a new credit union for formerly incarcerated people, and reached a critical milestone when the National Credit Union Administration (NCUA) gave us the green light to to apply for a federal credit union charter. First Step Alliance was named as an approved Membership Association for the new credit union by the NCUA.

First Step Alliance is a New Jersey registered 501(c)(3) non-profit organization committed to increasing financial inclusion and economic empowerment for justice-involved individuals. We are a team of experienced financial services professionals and formerly incarcerated community leaders dedicated to ending systemic discrimination in mainstream banking for this highly underserved population.

Our **mission** is to help advance successful reentry and sustainable financial independence for justiceinvolved individuals by improving access to the financial information and affordable banking resources people need to create a path to long-term financial health. Our **vision** is to start a new credit union dedicated to this community and help make large-scale change to the systemic banking issues millions of people face.

Fresh Start Financial Education

Our goal is to empower people with the knowledge and tools they need to achieve sustainable financial independence:

- Free online financial education learning program
- Helps people develop responsible money management habits and build credit
- On-demand learning in both English and Spanish through a smartphone, computer, or tablet
- Designed to accommodate a wide range of learning styles
- Individual credit counseling services also available
- Program available at correctional facilities through secure learning platforms

Banking Program

Access to affordable banking is an integral part of successful reentry and helps people create a path to credit building and economic mobility.

Fresh Start Banking

First Step Alliance makes this Program available through partnerships with established credit unions that offer fair and inclusive financial services. The Program features a mobile banking app that can be downloaded on either an iPhone or Android device:

- No-minimum, no-credit check, no-fee checking account
- Visa debit card
- Direct deposit of paycheck
- Thousands of surcharge-free ATMs across the country
- Mobile deposit of checks
- Cash deposits through ATMs
- 2-day early payday with direct deposit
- Banking app available in English or Spanish



Additional Activities

Alabama ID and Financial Services Project

First Step Alliance partnered with Greater Birmingham Ministries and the Jimmy Hale Mission for an initiative aimed at improving access to identification documents and financial services for returning citizens in Alabama. This collaboration resulted in the publication of the *Alabama Reentry Guidebook*, a uniform resource manual that includes detailed information on obtaining important ID documents and where to access affordable banking services.

The *Guidebook* is intended for use by the Alabama Department of Corrections, state agencies and local reentry organizations. The Financial Health Network provided a generous grant for this project. Click on the image below for a link to the *Guidebook*.



Association for Enterprise Opportunity (AEO) Program Cohort

AEO launched the Endeavor Ready initiative to identify solutions needed to successfully prepare returning citizens for entrepreneurship, including early credit-building, right-fit capital, and trauma-informed care. First Step Alliance was selected to participate in its 2022 cohort to help AEO gain additional insight into these challenges and what steps financial institutions can take to improve access to capital.



National Reentry Workforce Collaborative (NRWC)

First Step Alliance was invited by Vera Institute of Justice to participate on an *Equity & Inclusion* conference panel to discuss systemic discrimination in financial services and how First Step Alliance is addressing this issue. NRWC is the only national organization founded by workforce practitioners committed to advancing socio-economic mobility for people impacted by the justice system (https://thenrwc.org).

Building Community Awareness

By leveraging social media and our Google Ads grant, we significantly increased website traffic and raised community awareness for our organization and its mission. Several of our published articles played a key role in achieving these results:

- Reducing Recidivism: Creating a Path to Successful Reentry (31,000 views)
- What We Can Learn From Norway's Prison System (22,000 views)
- The First Step Act What Is It And How Does It Affect The Justice System? (11,000 views)

In addition, several known publications, including **American Banker, Business Insider**, **and Credit Union Times**, interviewed or cited First Step Alliance for articles on financial inclusion for returning citizens.

Through relationships with reentry and other community organizations, our Fresh Start Financial Education and Banking Programs have reached many people in need. In addition to continuing to expand these partnerships in 2023, we will focus our efforts on launching a new credit union for formerly incarcerated people. **Diverge Proposed Federal Credit Union** will provide a **"financial home"** for these individuals and their families, offering access to a wide array of financial products and services specifically tailored to the needs of this community.

The Diverge Organizing Members have received extensive support from government regulators, politicians, the credit union industry, and community and social justice organizations. The Organizers are in the process of seeking initial funding to operationalize the credit union and aim to open its doors in 2024.
